Subject: New Business Dr. Bouquillon discussed what his intentions are with the Building Committee at this meeting. Subject: New Business Letters from the MSBA	 Action/Who/When: Dr. B gave an idea of where we are with the MSBA and the School Committee. Dr. B familiarized everyone with the documents pertaining to the process, i.e. the letters from the MSBA. Dr. B expressed his desire to have all 16 district towns represented on the Building Committee. Action/Who/When: May 3, 2010- All the conditions from this important letter have been met. August 8, 2011- This letter lends to the urgency of this project, i.e. the emergency in the Trades Hall over the summer, life safety. The MSBA's letter from last week is the most significant. It discusses the final enrollment program and the 270 day eligibility period. The letters are accessible on the school's website. 	
Subject: New Business Enrollment Study	Action/Who/When: - The MSBA has said three things must be done before money is spent: an enrollment study, an educational program plan, and a look at the agreement. How can it be more equitable to all 16 towns? - The enrollment study was decided on by the MSBA at 800 students. There has been discussion at the School Committee level and within towns whether 800 students is the right size. That number does not include Post Graduates. - As the Feasibility Study continues, the MSBA knows there might be some adjustments, and that 800 may be a little low.	
Subject: New Business Expected commitment	Action/Who/When: - A couple meetings a month for 1-2 years. - The days and times will be discussed as a group to develop the best schedule. - Ford Spalding stated he sees a group of 25 people being an appropriate size for the beginning stages.
